WITHDRAWAL POLICY

- Once admission is granted, fees will not be refunded.
- Before withdrawing the child it is mandatory to give at least 3 months notice in writing prior to the end of the academic year i.e. latest by 31st December and clearance of all previous & current dues.
- If the notice period is less than 3 months, six months fees (of the following academic year) shall be charged.
- In case of withdrawal anytime after the commencement of the academic session, fees for 12 months shall be charged.
- School Leaving Certificate (Transfer Certificate) will be issued only after the clearance of dues in favour of the school.
- Security is refunded according to school rules mentioned in the prospectus.
